RECOMMENDATION:

THAT School District No. 34 (Abbotsford) Capital Plan Bylaw No. 2023/24-CPSD34-03 be given second reading.

THAT School District No. 34 (Abbotsford) Capital Plan Bylaw No. 2023/24-CPSD34-03, be given third reading, reconsidered, and finally passed and adopted on this 23rd day of January 2024.

BACKGROUND:

In April, the Ministry of Education advised they reviewed all 60 School Districts' Annual Five-Year Capital Plan submissions for Major Capital Programs and Minor Capital Programs to determine priorities for available capital funding in the following programs:

- Seismic Mitigation Program (SMP)
- Expansion Program (EXP)
- Replacement Program (REP)
- Site Acquisition Program (SAP)
- Rural District Program (RDP)
- School Enhancement Program (SEP)*
- School Food Infrastructure Program (FIP)
- Carbon Neutral Capital Program (CNCP)
- Building Envelope Program (BEP)
- Playground Equipment Program (PEP)
- Bus Acquisition Program (BUS)

In April 2023, the Ministry of Education and Child Care identified major capital projects supported to proceed to the next stage, as well as minor capital projects approved for funding and can proceed to procurement. Capital Plan Bylaw No. 2023/24-CPSD34-01 was approved at the April 11, 2023, Public Board meeting. Below is the table of projects approved.
