## 7.0 DELEGATIONS/PRESENTATIONS/ACKNOWLEDGEMENTS

7.1 <u>School Presentations: Auguston Traditional Elementary and Colleen & Gordie Howe Middle</u> Colleen and Gordie Howe Middle School Principal Shawn Davids, WEB Coordinators and student leaders attended and shared about the reinstatement of the Where Everyone Belongs program and how the program has positively influenced the beginning of their school year. Auguston Traditional Elementary School Principal Kris Sward and students attended and highlighted daily and weekly routines that students participate in to contribute to a school community of kindness, meaningful connections and relations, and ensuring a safe and welcoming space for everyone.

## 7.2 Back to School Event

Andrea Senft provided information about the Back to School Event which was hosted for elementary students this year on August 28, 2024. The annual event, in its fifth year, aims to support families with elementary school-aged children with essential school supplies and more. Over 4000 children have participated and have been supported by this annual event.

## 7.3 The King Charles III Coronation Medal

The King Charles III Coronation Medal was created to commemorate the coronation of King Charles III and Queen Camilla on May 6, 2023. Canada has issued 30,000 medals to select members of the Canadian Armed Forces and Public Service. Recipients of this medal must have made a significant contribution to Canada or to a particular province, territory, region or community of Canada or have made an outstanding achievement abroad that brings credit to Canada. Superintendent Nosek announced that we have recently learned that Deputy Superintendent Nathan Ngieng had been nominated by the Minister of Education, Rachna Singh and has been awarded The King Charles III Coronation Medal.

## 8.1 2024-25 School Start Up Report

## 8.2 Framework for Enhancing Student Learning (FESL) Report

Superintendent Nosek and Assistant Superintendent Cunnings presented the Framework for Enhancing Student Learning Report, which highlights the progress made in literacy, numeracy, student well-being, careers, and graduation rates in the 2023-24 school year. This report is a vital means through which the Board of Education conveys our accomplishments from the previous school year to the broader community. The report will be submitted to the Ministry of Education and Child Care by Tuesday, October 1, 2024. In keeping with the Board's Strategic Plan Governance Cycle, senior staff will attend upcoming public board meetings to report on progress made in the 2023-24 school year and the plans for 2024-25 in their respective departments. The annual Measuring Up report will be presented to the Board of Education in November 2024.
